Check SMART CCDO cards with the Go SMART App or older style CCDO cards via the CITB online card checker website.



Duties:


- The Demolition Site Visitor card is intended for those individuals with no specific demolition skills or functions.
- Examples of roles requiring the Site Visitor card are: Plant Fitters, Site Photographers, Company Administrators, Human Resources Personnel and Security Staff.
- Site Visitors should have a knowledge of site safety, hazard awareness and demolition site navigation.



CCDO
NFDC Approved Auditor
5 Year Renewable Card

Duties:

- Competent professional approved to conduct the NFDC / CHAS approved site audit.
- Maintain up to date knowledge of relevant legal changes to the demolition and other relevant industry sectors
- Undertake the audit in a uniform, fair and respectful manner so that all NFDC and prospective NFDC members have an equal audit
- Communicate effectively, both verbally and in writing.



CCDO
Demolition Labourer - Level 1 Equivalent
5 Year Renewable Card

Duties:

- General labouring duties under supervision as directed by Chargehand or above.
- Assist teams of CCDO Demolition Refurbishment Operatives and CCDO Topmen in the clearing of arisings from the demolition processes being undertaken.
- Ensure the correct segregation of wastes prior to removal from the demolition site.
- Assist in the soft strip function under the guidance of a Chargehand or Supervisor where required.

Duties:

- This cardholder must not be left working alone and should be in close contact with their company mentor throughout their program.
- The apprentice is given multiple theoretical and practical training courses.
